Dear Committee Members:

I am writing to give you a final report related to your support of the Asante Cancer Compassion Fund. As you know, through the Asante Cancer Compassion Fund you serve the needs of cancer patients, both basic needs and comfort needs. Assistance is based on need and is designed to respond to the unique medical circumstances of every patient and their family.

For someone in the battle of their life, expenses can quickly become a financial hardship and an overwhelming distraction from their healing process. The Compassion Fund provides the ability to help patients and families who need that extra bit of assistance to help them live the best quality of life while going through cancer. In addition, these funds support programs that bring peace of mind during a time that is extremely stressful.

Over the past year, funds have supported a variety of activities and causes:

- Travels expenses, gas cards, bus passes, and care repairs
- Monthly rent and car payments for patients who were unable to work during their treatment
- Cancer-related care items not covered by insurance such as ointment, doughnut cushions, formula and feeding tubes- transition kits for neck and throat cancer patients
- Complimentary therapeutic hand and foot massage reducing stress, promoting healing and providing emotional support during infusion
- Critically needed dental care for a head and neck cancer patient – without oral care radiation would have resulted in necrosis of the jaw bone
- Support group materials including nutritional cookbooks for GYN cancer patients
- Temporary housing in Seattle for a local patient to receive advanced treatment
- Thanatology, a palliative care method of therapy that unites music and medicine bringing harp to the bedside, meeting fear, discomfort, and suffering through the therapeutic qualities of music

Your gift to this special fund has impacted many more than we will ever truly know. The impact goes far beyond the patient. I have heard from numerous family members whose loved ones are going through cancer treatment share their gratitude and relief when their loved one receives hope and kindness through these efforts.

In addition, I hear from social workers and nurses on the front lines who are disbursing the funds about the joy they experience as they help make lives of their patients just a little easier.
